



# Customs Guide for guests of Pridnestrovie



Personal belongings, personal jewelry, still and movie cameras and accessories, portable musical instruments, portable personal computers and accessories, cellular phones for personal use, sports and camping equipment, baby strollers can be brought into Pridnestrovie through the Green channel without paying duty.



A person aged 18 and over can bring in alcohol free of duty for personal use no more than the following amounts: beer – 5 litres, spirits of 40% volume of ethyl alcohol and more – 2 litres, wine and other alcoholic beverages – 5 litres.



A person aged 18 and over can bring in free of duty for personal use no more than 200 cigarettes and cigarillos, or 200 gr of tobacco or tobacco products.



Foreign currency in cash and cheques in foreign currency in amount not exceeding USD 5 000 (or equivalent in other currencies) per person are allowed without declaring in writing.



Fuel can be freely moved across the border in amount not exceeding the limits of full fuel tank of the vehicle crossing the border.



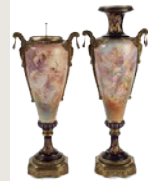
A person is allowed to bring in food for personal use in the following amounts: fresh, chilled and frozen meat – 3 kg, ready meat products – 3 kg, vegetable oil – 5 kg, milk – 3 kg; dairy products – 3 kg, fruits – 50 kg, vegetables – 50 kg, other food products in the value not exceeding USD 200, with the exception of excisable goods.



Personal medicines containing narcotic, psychotropic and drastic substances must be declared in writing (by filling in goods declaration without paying duty) and be accompanied with a document confirming the need of taking medications (eg. medical prescription).



Weapon, its parts and ammunition carried for sports purposes or for executing official duties with the total value under USD 10 000 (in equivalent) must be declared in writing (by filling in goods declaration) and be accompanied by authorization to carry issued by competent agency.



Works of art, collectables, and antiques must be declared in writing (by filling in goods declaration without paying duty) and be accompanied by a document confirming ownership as well as import/export license for cultural values.



Other items for personal use are allowed up to USD 1 000 (in equivalent) in the total value and with the total weight not exceeding 50 kg



In case of entering Pridnestrovie by car for personal purposes goods declaration for temporal admission of a vehicle must be submitted to Customs.

Road fees as well as car insurance policy are required on entering Pridnestrovie.

The State Customs Committee of Pridnestrovie is temporarily authorized to issue car insurance policies and collect insurance premiums at customs check points across the border.

## Attention!

### Goods prohibited both on entering and leaving the country:

- poison, radioactive, explosive substances, firearms, explosive devices, nuclear, chemical, biological and other types of weapon of mass destruction, materials and equipment that may be used to produce weapon of mass destruction, combat weapon, its parts and ammunition;
- narcotic, psychotropic substances and their precursors, drastic and poisonous substances, plants containing narcotic and psychotropic substances.

### Prohibited imports:

- tobacco and tobacco products, alcohol, frozen meat and ready meat products, and cellular phones in case of exceeding limits established for personal use.

### Prohibited exports:

- Pridnestrovie's national currency in cash (banknotes and non-precious metal coins) exceeding in total USD 5 000 in equivalent, and Pridnestrovie's national currency in cash (precious metal coins) exceeding in total USD 10 000 in equivalent based on the selling price of these coins established by Pridnestrovian Republican Bank.
